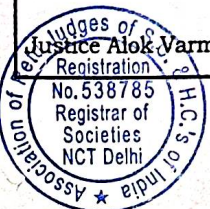

## MINUTES OF THE MEETING OF THE EXECUTIVE COMMITTEE OF THE ASSOCIATION HELD ON 26.04.2026 AT 10AM IN THE CONFERENCE HALL, OF HOTEL CLARION BELLA CASA, JAIPUR (RAJASTHAN).

The office bearers and the Chairpersons or their nominees of the state chapters, who were present in the meeting, appended their signatures on a separate sheet which forms part of the minutes.

The quorum of the meeting was complete.

The President Justice K. L. Sharma, presided over the meeting. At the outset the President welcomed all the office bearers, chairpersons and the Advisor Justice P.S. Gopinathan, who attended the meeting.

The Secretary General presented notes on each and every item of the agenda in the meeting, one by one.

**Agenda No.1 :** Confirmation of minutes of the meeting dated 17<sup>th</sup> January 2026, of the Executive Committee held in Tamil Nadu State Judicial Academy, Chennai.

Resolved that the minutes of the meeting dated 17.01.2026, held at Chennai, be confirmed and are hereby confirmed.

**Agenda No.2 :** Information about the new members of the Association.

The Secretary General informed that since the last meeting of the Executive Committee was held at Chennai, twenty new members have joined the Association. Their names were also read out by the Secretary General. It was also informed that during the last financial year 2025-26, total 30 new members joined the Association. The names and other details of the new members have been uploaded on the Association website [www.arjschc.com](http://www.arjschc.com) and also on the whatsapp group (mob. No. 8957076387) of the Association.

It was also apprised by him that he has sent letters along with membership forms, to the Secretary General, Supreme Court and the Registrar Generals of all the High Courts, requesting them to kindly circulate the same amongst all the sitting as well as former judges, so that they may know about the existence of the Association and willingly opt membership. A request was also made to the members to kindly contact individually the superannuating judges wherever they are residing and pursue them along with membership form for joining our Association and clear their doubts if any.

**Agenda No.3 : Consideration of the activities of the Association during the financial year 2025-26**

The Secretary General Justice Mahendra Dayal presented the annual report informing the members about the achievements of the Association during the last financial year. It was informed by the secretary general that in the last AGM held at Bangalore on 19.4.2025, the Association published a souvenir with list of members state wise. Apart from the list of members, rules, bye-laws, important orders, list of office bearers, formats and many more important information regarding association is printed. The souvenir was formally released by the President Justice K.L. Sharma during the last AGM and the copies of the souvenir were provided free of cost to all the members.

The Secretary also informed that the website of the Association has proved very beneficial for the members who get every-information about the activities of the association including notice, agenda and minutes of the meeting with photographs. The rules and bye-laws of the association are also available on the website. The details of the office bearers with their phone numbers and pictures are available on it. The list of members state wise is also available. It was requested by the Secretary General to the members to make full use of the website.

The Secretary General also informed that the chief Justices conference held on 7<sup>th</sup> and 8<sup>th</sup> February 2026, took up the issue in its agenda on the request of the President Justice K.L. Sharma for providing protocol facilities by all High Courts to visiting former Judges of Supreme Court and High Courts. The issue was discussed at length and further action was suggested.

It was also informed that in compliance of the order passed by Supreme Court in the contempt case filed by our patron Justice V.S. Dave, most of the states have issued orders

to provide allowance to the former judges equal to that of the former judges of Andhra Pradesh and it is expected that the remaining state governments will also issue similar orders in compliance of the order of the supreme court.

**Agenda No.4 :Consideration of the financial statement for the year 2025-26**

The secretary general on behalf of the treasurer presented the annual financial report for the year 2025-26 and apprised the committee about the assets of the association. It was informed by him that the total income of the association from the membership fee, interest and refund of income tax was Rs. 4,47,670/-. The expenditure of the association in holding meetings, purchase of stationary, website maintenance, recharge of mobile phone and postal expenses was only Rs. 1,87,148/- and thus the association had a saving of Rs. 2,56,524/- which is more than the expenditure.

**Agenda No.5 :Consideration of the budget estimates for the financial year 2026-27**

The Secretary General Justice Mahendra Dayal, on behalf of the Treasurer presented following budget estimates for the financial year 2026-27 which the executive committee accepted and resolved that the same be placed before the AGM for approval.

Justice J.K.Ranka, Vice-President, In-Charge State Chapter, presented his report and informed that as a result of his persuasion to the former judges of the Supreme Court and High Courts of various states, a large number of former judges have taken membership of the association. The achievement of Justice Ranka was appreciated by all the members due to his sincere efforts and ability of persuasion.

**Agenda No. 8- Proposal for the appointment of the auditor for the next financial year 2026-27**

The executive committee, considering the performance of the auditor M/s Shailja Agarwal and Associates, recommended that the same auditor be appointed for the next financial year 2026-27. It was resolved that the recommendation be placed before the AGM for approval.

**Agenda No. 9.: Consideration of date, time and venue for the next meeting of the Executive Committee to be held in the month of July 2026.**

The Secretary General informed that the registered office of the association is in Delhi High Court and no meeting has been held there since last one year. It was unanimously resolved that the next meeting of the Executive Committee to be held in the month of July 2026 be held at Delhi High Court, campus, on 18<sup>th</sup> July 2026 at 10.30AM. It was also resolved that formal letter of request for holding meeting in Delhi High Court, be sent to the Hon'ble Chief Justice for his consent.
